Few investors are aware of the fact that a violation of the FBA constitutes a criminal offence. Especially the use of Thai nominee shareholders is strictly illegal.

- how to make corporate structures legal and compliant with the onerous provisions of the FBA
- in which manner foreign majority ownership in a Thai company can be legally achieved and
- how a violation of the FBA can be avoided.
